- "3. (1) No child shall he employed or permitted to work in any occupation or process.
 - (2) Nothing in sub-section (1) shall apply where the child.-
- (a) helps his family or family enterprise, which is other than any hazardons occupations or processes set forth in the Schedule, after his school hours or during vacations;

entertalmment or sports activities except the circus, subject to such (b) works as an urlist in an audio-visual emertainment industry. inchuding advertisement, films, television serials or uny such other conditions and sufety measures, as may be prescribed:

Provided that no such work under this clause shall effect the school education of the child.

Explanation. For the purposes of this section, the expression,

(a) "family" in relation to a child, means his mother, father, brother, sister and father's sister and brother and mother's sister and

- (b) "family enterprise" meuns any work, profession, manufacture or business which is performed by the members of the family with the engagement of other persons;
- (c) "artist" means a child who performs or pructices any work as a hobby or profession directly involving him as an actor, singer, spares person or in such other activity os may be prescribed reluing to the entertainment or sports activities falling under clause (b) of sub-section
- The Child Labour (Prohibition and Regulation) Act, 1986 also provides the provisions to regulate the conditions of work of children in certain other employment and penaltics for violation of the law.
- As regards involvement of minor children in election related activities, the Hon'ble Bhutada Vs. State of Maharashtra and others). stressed the need to ensure that political parties do Bombay High Court in its Order dated 4th August, 2014 in PIL No. 127 of 2012 (Chetan Ranılal not allow participation of minor children in any election related activities.
- The Commission has always taken strong exception to use of children in any way in election related work and has issued instructions in this regard from time to time. The Election Commission of India had directed that no child should be involved in election process by political parties and election officials.
- In supersession of all the existing instructions on the subject regarding Child Labour and keeping in view of the Child Lubour (Prohibition and Regulation) Act, 1986 and the Child Labour (Prohibition and Regulation), Amendment Act, 2016, the Commission has decided to issue the following consolidated instructions for compliance of all electoral authorities and political parties/candidates in future.

(a) For Election Muchinery:

- election related work/activities. (i) All Election Officials/machinery should refrain from involving child labour in any
- (ii) The District Election Officers/Returning Officers shall be personally responsible for action apart from facing the consequences of law. if any such instance comes to the any such violation of Acts/laws by election machinery and will face severe disciplinary notice of the Commission.
- (b) For Political Parties/Candidates and their agents/representatives etc:-
